- 3) Contestants will be limited to a three minute performance per round.
- 4) The Organization will not be held responsible for faulty CDs provided by contestants; therefore, the Organization recommends testing CDs prior to submission for performance.
- 5) If necessary, any ties between contestants will be broken by Judges’ scoring and/or deliberation. Judges’ decisions are final, and will not be argued by any contestant or their affiliates.
- 6) Contestants and their affiliates will respect the Organization’s Management, Staff, and Judges at all times.
- 7) Contestants and their affiliates will not be allowed to approach the tech booth at any time, unless specifically asked by Management or Staff of the Organization.
- 8) All event attendees, with the exception of participants, will be required to purchase a ticket. **Seating is on a first-come first-serve basis, therefore all members in your party must be present. NO SAVING OF SEATS WILL BE ALLOWED.**
